Memorandum Of Understanding

This Memorandum of Understanding (MOU) is made on 11th of March, 2022 at Kampur, Nagaon.

BETWEEN

Kampur College affiliated to Gauhati University having its campus at Kampur, Nagaon, Assam, Pin-782426 (hereinafter called the First Party which expression shall where the context so admits, include its successors, permitted assigns will include its constituents) of the ONE PART.

AND

SELF-DEFENCE ALL STYLE MARTIAL ARTS ASSOCIATION, Assam, member of Self-Defence All Style Martial Arts Federation, India, Recognized by International All Sports and Games Federation (hereinafter called the Second Party which expression shall where the context so admits, include its successors, permitted assigns will include its constituents) on the OTHER PART.

Whereas,


1. The second party (All Style Martial Arts Association) shall provide teacher and necessary game items like Taulu, Long stick, nun saku etc for the road fight, market fight, game fight training to the students enrolled from the college. The first party agrees to provide the indoor stadium and college field to the students for classes.
2. After course completion the certificate of the courses shall be jointly provided by the first party and the second party under the society registration number of the second party.
3. The examination of the courses offer shall be conducted by the second party.


4. The first party (Kampur College) will collect the admission fee, monthly fee, re-admission fee only (but not examination fee) from the students and deposit the money in Kampur College Bank account to smoothly run the course with the second party. The first party shall provide the second party holding in the monthly revenue.
5. The total monthly revenue of the courses shall be mutually divided by the first party and the second party. Out of the total revenue both the parties will have equal hold i.e., of 50%-50%.
6. In case of admission to the course 100% preference will be given to the college students. However, if any seat remains vacant that will be filled by outsider.
7. College will provide facilities like drinking water, washroom, canteen etc to trainers and staffs.

This agreement will take effect from the date of signing and shall be valid for two years period from that unless sooner terminated, revoked OR modified by mutual written agreement between the parties and may be extended by mutual written agreement.


Either party may terminate the agreement at any time during this term by the provision of three months written notice to the other party.
